



CUSTOM CONTROL TECHNOLOGIES ENGINEERED PRODUCT "LIMITED" WARRANTY

During the time period subject to the conditions hereinafter set forth, CCT will repair or replace to the original user or consumer, any portion of a CCT product which proves defective due to defective materials or workmanship of CCT. Original Consumer must contact CCT Warranty Department for warrant service. At all times CCT shall have and possess the sole right and option to determine whether to repair or replace defective equipment, parts, or components. Damages due to conditions beyond the control of CCT is **NOT COVERED BY THIS WARRANTY**. (Contact parcel or freight company for claims on freight damaged in transit)

WARRANTY PERIOD: CCT shall warrant all Engineered Products and Accessories for a period of 18 months from the date of Manufacture.

LABOR, ETC., COSTS: CCT shall IN NO EVENT be responsible or liable for the cost of field labor or other charges incurred by any customer in removing and/or re-affixing any CCT product, part or component thereof.

CUSTOMER SUPPLIED COMPONENTS: In no way shall CCT warrant any customer supplied components or any damages found to be caused any the supplied component.

THIS WARRANTY WILL NOT APPLY: (a) To defects or malfunctions resulting from failure to properly install, operate or maintain the unit in accordance with printed instructions provided; (b) to units which are not installed in accordance with applicable local codes, ordinances and good trade practices; (c) if the unit is moved from its original location, or; (d) if the unit is used for purposes other than for what it was designed and manufactured; (e) failures resulting from abuse, misuse, accident, or negligence; (f) product will not be warranted if damaged or any malfunction is caused by an "Act of God"

PRODUCT IMPROVEMENTS: CCT reserves the right to change or improve its products or any portions thereof without being obliged to provide such change or improvement of units sold and/or shipped prior to such change or improvement.
